

INTERNATIONAL COOPERATION BETWEEN FRANCE AND KAZAKHSTAN IN THE FIELD OF HIGHER EDUCATION

ACADEMIC MOBILITY OF KAZAKHSTANI STUDENTS

In 2022, 101 students of RK (ENU – 1, KazNU – 31, KazNMU – 1, KazNPU – 9, ZHENPU – 3, AIMU – 27, KAZUMOIMYA – 1, MUA – 1, KIMEP – 19, UMB – 2, KBTU – 3, MUIT – 1, Narkhoz - 2) passed academic mobility training in French universities (ESC Rennes Business School, EU Business School, Excelia Group, Graduate School of Management, Institut Jean Lamour, Pôle Universitaire Léonard de Vinci, University Gustave Eiffel, University of Poitiers, Catholic University of Lille, IESEG School of Management, Toulouse Business School, University of Lorraine, University Perpignan Via Domitia). Mainly in the field of Business, management and law, Pedagogical Sciences.

ACADEMIC MOBILITY OF FRENCH STUDENTS

In 2022, 17 French students (Excelia Group – 3, IESEG School of Management – 2, Sciences Po Bordeaux – 11, University of Toulouse – 1) studied at AIMU – 4, KazGUU – 2, KazNU – 11 in the specialties of International Relations – 12, Management – 5.

INTERNATIONAL STUDENTS

In the 2022-2023 academic year, 3 students from France are studying at KazNPU. Abay is in the 4th year of bachelor's degree in the specialty 6B04202 International Law: European Law and International Law and 2 students at KIMEP in the 1st year in the specialty International Relations.

ACADEMIC EXCHANGE OF TEACHING STAFF

In 2022, the academic exchange of teaching staff between Kazakhstan and France was carried out in the following OVPO:

- Almaty Management University and Gustave Eiffel University, (academic mobility 2 kaz. Teaching staff in online format)

- Almaty Management University and the Embassy of France in Almaty, Skema Business School (academic mobility 2 fr. Teaching staff in online format)

In total, 14 PS from Kazakhstan participated in the academic exchange programs with France in the online format and 2 teaching staff from France.

ATTRACTING SPECIALISTS FROM FRANCE

In 2022, 25 specialists from France were involved in teaching in 6 OVPO of Kazakhstan, 22 of them at the expense of extra-budgetary funds (Table 1), 3 specialists at the expense of the republican budget (Table 2). Of these, 18 are in offline format, 7 are in online format.

INTERNATIONAL AGREEMENTS

27 Kazakhstani OVPO have signed **84** agreements with French **educational organizations** in the field of science and education, exchange of teaching staff, researchers and students, academic mobility of students, holding competitions, conferences, co-supervision of master's and doctoral dissertations.

At the same time, **5** OVPO participate in **8** international projects for the implementation of joint educational and scientific projects together with partners from France (Table 1).

4 Kazakhstani OVPO together with partner universities are implementing **8** double-degree programs (hereinafter referred to as DDP), of which **4** DDP are in English. The contingent of students in road accidents for 2022 is **127** people (Table 2).
